West Coast Climate Campaign: A multi state effort that encompasses two coalitions working to price carbon and develop and advance well-designed, technically sound climate policies, advocating for them in the legislative and regulatory realms. In Oregon the Coalition has a 65,000 person email list and growing, 28,500 followers on social media and is well on the way to engaging our goal of 100,000 Oregonians. In Washington we succeeded in advancing policy that facilitates the closure of 2 of Colstrip's generators Units 1 and 2. Shutting down these two units will eliminate 5 million tons of carbon emissions annually.

Fossil Fuels Program: The Power Past Coal and Stand Up to Oil coalitions are now working collectively to prevent the Northwest from becoming an international fossil fuel highway. 27,000 people demonstrated solidarity with the Lummi Nation, asking the Army Corps of Engineers to deny a coal export permit at Cherry Point based on Lummi treaty rights. coalition submitted more than a quarter of a million comments opposing a coal export mega project in Longview, WA, and helped turn out more than 1,000 people to attend public hearings on the proposal.
